COMMISSIONER COMMENTS:

Commissioner Rocha asked that someone go out to the corner of Bardsley Avenue and Blackstone Street and check for line of sight. She stated that the bushes are overgrown again.

Commissioner Miller stated that the landscaping at the north end of Solaria is completely dead. Commissioner Miller also asked staff what the zoning designation was for a parcel on the East side of Mountain View, between Tulare Avenue and Academy Ave.

Director Myers stated that she would research it and get back to the Commissioner.

Commissioner Miller further noted that the County is in the process of redistricting and there will be a meeting for all citizens to attend on July 1st at the Agri Center social hall and it starts at 5:30 or 6:00 p.m.

Commissioner Cox noted that the City Council will be voting on the new budget and stated that Public Works department is in need of additional resources for their bin rentals. He stated that it is weeks to get a bin and days to get it emptied and the City does not allow for the use of outside private companies. He hopes that the City Council approves the request by the Public Works Department for additional help in this matter.

PUBLIC HEARING:

(1) Conditional Use Permit No. 2021-07:

Steven Sopp, Senior Planner, reviewed a request by Chandi Enterprises, LLC to construct a service station and convenience store. This application also includes a request to obtain an ABC license (Type 20). The project is located at the north side of Prosperity Avenue, west of Mooney Boulevard.

Chairman Miguel opened the public hearing.

There being no one to speak in favor of or against the project the public hearing was closed.

Commissioner Rocha stated that she is concerned that the back of the gas station faces the entrance off of Prosperity Avenue and asked if there would be some type of landscaping in the back.

Andy Alvilar, representative for Chandi, LLC stated that there would be lattice and landscaping along the back of the building.

Commissioner Miller asked if the applicant chose the location for the gas station.

Mr. Alvilar stated that this was the location the applicant chose.

Following Commission discussion it was moved by Commissioner Miller and seconded by Commissioner Rocha to adopt Resolution 5393, approving Conditional Use Permit No. 2021-07 based on the findings and subject to the conditions as listed in the staff report.
