I. CALL TO ORDER

The Regular Meeting of the Tulare Parks and Recreation Commission was called to order at 6:30 a.m. by Chairperson Craig Hancock at the Claude Meitzenheimer Community Center.

II. PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was led by Mike Jamaica.

V. CONSENT CALENDAR

(1) Commission minutes of June 11, 2024 regular meeting.

It was moved by Commissioner Farrenkopf, seconded by Commissioner Sherwood, and unanimously carried to approve the items on the Consent Calendar as presented.

VI. SCHEDULED CITIZEN OR GROUP PRESENTATIONS

VII. GENERAL BUSINESS

(1) Elk Bayou Soccer Complex Agreement – Brian Beck

Assistant Community Services Director Brian Beck reported that Recreation Supervisor Capote held meetings with AYSO and TYSL and was key in getting this agreement organized with equal playing time and field dimensions for both leagues with consistent field markings. Both organizations are playing both Saturday and Sunday. Commission Chairperson Hancock

motioned and Commissioner Sherwood seconded to approve the agreement. The motion unanimously carried.

(2) Administrative Items – Jason Glick

Community Services Director Jason Glick invited the Commission to the ground breaking of the dog park on Tuesday, August 27, 2024 at 9:00 a.m. at 407 North O St.

Zumwalt Park construction is ongoing. First concert is scheduled on October 26, 2024, although park construction will not be completed until this winter.

Community Services Director Glick announced that Friday, August 16, 2024 will be his last day in this department. He will be returning to Visalia Parks and Recreation Department as Director. Assistant Community Services Director Beck will be acting Community Services Director until the position is filled.

(3) Attendance, Recreation, and Cost Recovery Reports, Upcoming Events - Brian Beck

Assistant Community Services Director Beck reported that softball numbers have increased. Recreation Supervisor Capote has done a good job in getting teams from other towns, holding people accountable and changing the dynamic of the softball program. Game times were modified due to heat. He has also kept the adult volleyball program going this past year, unlike the previous year. BEST Club is down slightly from last year due to keeping kids off waiting lists and enrolling them in alternate programs if BEST Club us not offered at the school where they attend. Summer Camp attendance numbers are up this year compared to last year, even with school district offering a free program. Our fees were discounted, but we still received more enrollments than last year. Movies in the Park numbers were down slightly. It was very hot this year, and may be doing something different next year. Public Swim numbers were about the same as last year, instructional swim numbers did increase from last year. Youth tennis numbers were up this year. We were able to use the same instructors as last year and times were modified because of heat. Programs are getting ready to start for fall. 190 meals per day are currently being served at the Senior Center.

(4) Parks Division Monthly Report for Report – July 2024

Parks Maintenance Manager Ivan Nicar announced that the Parks Department is currently 3 positions short, and Parks staff under the direction of Parks Supervisor Rick Murch are working very hard to keep all locations maintained properly until those positions are filled. Along with the regular parks maintenance Ivan outlined completed projects including tree removal and pruning, irrigation repair, addition of EWF (Engineered Wood Fiber) playground chips and transient encampment cleanup in parks. Upcoming

projects include adding EWF (Engineered Wood Fiber) chips to playgrounds, tree pruning and parking lot prep at Elk Bayou Soccer Complex, demolition of Tyler Park dumpster enclosure and solar bollard improvement project at Willow Glen Park. There was a total of 480 of volunteered community service hours.

VIII. ITEMS OF COMMISSION INTEREST

Chairman Hancock addressed the Commission regarding the recent Supreme Court issuing its opinion of Grants Pass v. Johnson making it easier for communities nationwide to fine, ticket and arrest people who live unsheltered even when no adequate shelter is available. Governor Newsome then stated that this ruling from the Supreme Court provides state and local officials the authority to implement policies to clear unsafe encampments from our streets. By this ruling taking place this should put the homeless issue back into the responsibility of PD, Health and Safety, and Code Enforcement.

IX. ADJOURNMENT

The meeting was adjourned by Chairperson Craig Hancock at 7:06 a.m.

Agenda Title: Parks Division Monthly Report – September 2024

Acreage Maintained: The Parks Division maintains 408 acres of landscape and grounds which include 299 acres of parkland, 76 acres of Landscape Maintenance Districts, approximately 33 acres of green belts, medians, and tree-lined streets, and 5 miles of Tulare Santa Fe Trail.

PARKS

Maintenance:

- Restrooms (13) 7 days per week opening/closing, cleaning, stocking supplies, and repairs;
- Picnic Shelters 7 days per week cleaning BBQs, tables, and surfaces;
- Playgrounds (26) weekly safety inspections, repairs, trash removal;
- Tennis Courts (3) daily opening/closing, lighting repairs, surface cleaning, net repair replacement;
- Tulare Santa Fe Trail (5 miles) maintenance and repair as needed;
- Parks (20) litter clean up, servicing trash containers, graffiti removal, lighting inspections (arbors, trail, sports fields, parking lots) set programs, irrigation systems check including VFDs, calculating ET values, programming, repair as needed citywide communications for LAGUNA (central command irrigation management system), weather station service, sprinkler head adjustments, valve repairs, mainline repairs; herbicide applications for weed management; pesticide monthly usage reports to the State of California DPR; Del Lago Park Lake maintenance; parking lot clean up, tree and shrub pruning;
- Maintenance contract inspections and compliance for mowing (126 Acres)
- Public assistance; Street Tree/Heritage Tree inspection/removal requests.

Projects:

Completed:

- Senior Center pruned nine (9) Pistache trees along F St.
- Live Oak Park added approximately 70 cubic yards of EWF (Engineered Wood Fiber) playground chips.
- Cesar Chavez Park mainline irrigation repair, removed and replaced approximately 50 sq. ft. of concrete sidewalk.
- Elk Bayou Soccer Complex pruned (laced) 18 Pine trees along the perimeter.
- Parkwood Meadows added approximately 40 cubic yards of EWF (Engineered Wood Fiber) playground chips.
- Community Center structurally pruned 6 trees and removed 1 large Stone Pine tree (hazard).
- Prosperity Sports Park Musco LED stadium lights upgrade was completed.
- Transit Center pruned 15 Palm trees and 3 Live Oak trees.
- Downtown District pruned twelve (12) Pistache trees along K St. between Cross and San Joaquin.

- Bender Park removed vandalized playground chips due to fire and added approximately 85 cubic yards of EWF (Engineered Wood Fiber).
- Downtown District pruned 6 trees along the Downtown Public Parking Lot of "L" St. north of Howell's.
- Elk Bayou Soccer Complex troubleshoot and replaced several electrical wires for the stadium lighting.
- Willow Glen Park installed eight (8) solar bollard lighting.
- Bardsley Underpass repair frequently vandalized irrigation system and backfilled numerous soil erosions.

Upcoming Projects:

- Mulcahy Park add approximately 20 cubic yards of EWF (Engineered Wood Fiber) playground chips.
- Tyler Park add approximately 30 cubic yards of EWF (Engineered Wood Fiber) playground chips.
- Santa Fe Trail install tamperproof electrical conduit and lighting system for the Freeway 99 overpass.
- KCOK Ph 3. pocket park with playground, landscape, and irrigation inspection, 12-month maintenance period.

Community Service:

• Total of **480 hours** of volunteered community service.

Tulare Cares Temporary Encampment:

• Parks staff spent over **116 Hours** on document filing, maintenance, and operation.
