Conditional Use Permit No. 2017-13:

Deputy Director Myers, reviewed with the Commission a request by Tacqueria Michoacan (Veronica Ortiz) to continue to operate a stationary mobile vending vehicle on property located at 1414 W. Tulare Avenue. Deputy Director noted that in the staff report it indicates no tables and chairs for outdoor dining, however, the applicant has indicated in an interest on having one table and a few chairs located south of the vending vehicle should the Commission allow this.

Chairman Killion opened the public hearing.

Council Member Sigala spoke in favor of the project.

There being no one else to speak in favor of or against the project the public hearing was closed.

8) Applicant may set up 1 table with chairs for outdoor dining. Table and chairs are to be located on the south side of the vending vehicle and must be removed at the end of each business day.
